Reserve Bank of India

· President Pranab Mukherjee signed an ordinance giving more power to the Reserve Bank of India (RBI) to deal with the growing problem of non-performing assets.

The ordinance means an amendment to the Banking Regulation Act.

The amendment will give RBI the power to issue directions to banks to recover dues from loan defaulters, among others.

· The RBI has decided to introduce new batches for settlement of payments through the National Electronic Funds Transfer (NEFT) from July 10.

- The RBI said additional settlements in the NEFT system at half-hour intervals are being introduced to enhance the efficiency of the system and add to customer convenience.
- \cdot To avoid 'WannaCry' ransomware from spreading, the Reserve Bank of India (RBI) has asked banks to not operate ATMs till their software is updated.
- In this regard, RBI has asked banks to update specific Windows patches on ATMs urgently.
- The advice comes as over 60% of ATMs in India run on an outdated version of Windows and hence, are vulnerable to the attack.
- · The Reserve Bank of India (RBI) urged the banks to appoint qualified Chief Financial Officers (CFOs) and Chief Technology Officers (CTOs).
- The Reserve Bank of India (RBI) will soon put into circulation new notes in One Rupee denomination while existing notes and coins will continue to be legal tender.

State Bank of India

· The State Bank of India (SBI) has cut its term deposit rates by up to 50 basis points for various maturities.

The rates have been revised for medium and long term deposits and for amount below 1 crore. The lender offering the new rates for fresh deposits and renewals, applicable from April 29, 2017.

- · India's largest lender State Bank of India (SBI) has cut its interest rate for home loans up to 30 lakh by 0.25% to 8.35%, while those above 30 lakh saw a cut of 0.10%.
- · The State Bank of India (SBI) is going to introduce a new facility that would enable withdrawal of cash through ATMs using the bank's mobile wallet.
- · SBI has revised service charges on various cash transactions effective June 1, including a Rs. 25 charge on withdrawing money from an ATM through SBI's mobile wallet app.

Customers will be charged for exchanging more than 20 soiled notes and of value above 5,000. Basic Savings Bank Deposit account customers will get four withdrawals, including ATM

withdrawals, free in a month.

Other Banks

- · Kotak Mahindra Bank presents 811, India's first downloadable Digital Savings Account. Customers can open an 811 account in five minutes from their phone with just their Aadhaar and PAN details.
- \cdot ICICI Bank cuts home loan rate by up to 0.3% for loans up to 30 lakh to promote affordable housing.
- · Vijay Shekhar Sharma-led digital wallet Paytm launched its Payments Bank operations in Delhi-NCR, with 4% interest on savings account.
- · Uday Kotak, the billionaire head of Kotak Mahindra Bank, sold a less than 1% stake worth \$261 million (over 1,600 crore) in the lender, complying with an RBI order to cut his holding. The RBI

asked Kotak to lower his holding in the bank to 30% by June-end, 20% by December-end 2018, and to 15% by March 2020.

- · ICICI Bank CEO Chanda Kochhar has drawn 7.85 crore as total remuneration in 2016-17, a jump of nearly 64% from a year ago.
- · Russia's largest bank Sberbank is going to deliver cash via drones, its Deputy Chairman Stanislav Kuznetsov has announced.
- The cash delivered through the drones would come with certain security features like permanent ink taint to catch the thieves red-handed.

Supreme Court

· The Supreme Court upholds the conviction and death penalty to four convicts' Mukesh, Akshay,

Pawan and Vinay awarded to them by the High Court in the 16th December, 2012 Nirbhaya gang rape and murder case.

- The Supreme Court asked the state governments to issue a notification to include children affected with HIV in the disadvantaged group for imparting free, compulsory education under the 2009 law.
- · PM Narendra Modi launched the Integrated Case Management Information System (ICMIS) to help the Supreme Court go paperless. This system will help litigant's access data and retrieve information online.
- \cdot A 5-judge bench headed by Chief Justice of India JS Khehar has begun hearing petitions challenging the practice of Triple Talaq.
- · In a first, a Supreme Court bench found Justice CS Karnan of the Calcutta High Court guilty of contempt of court and sentenced him to six months in prison.

High Courts and Sessions Courts

· The Delhi High Court has ruled that the Income Tax Department has the powers to seize undisclosed money even from bank accounts not owned by a person being probed, as long as the department is satisfied the money belongs to that person.

Election Commission

- · Chief Election Commissioner Nasim Zaidi has announced that all future elections in the country will be held using Voter Verified Paper Audit Trail (VVPAT) machines along with the electronic voting machines.
- · The Election Commission was hold a live demo of EVMs and voter verifiable paper audit trails at Vigyan Bhawan in New Delhi.

The EC also give a press conference on the "EVM Challenge" hackathon, announcing its date and venue.

This comes after the AAP gave an EVM tampering demonstration on a dummy device in Delhi Assembly.

- · The Election Commission held a demonstration on the working of Electronic Voting Machines (EVMs) and Voter Verifiable Paper Audit Trail (VVPAT) System to prove that the machines are tamperproof.
- \cdot The candidates fighting election will now have to declare their as well as spouse's sources of income while filing nominations.
- · African country Botswana is going to use India manufactured Electronic Voting Machines (EVMs) with the voter verifiable paper audit trail for its 2019 general elections.

Central Government

- · After PM Narendra Modi pitched for shifting to a January-December financial year, Madhya Pradesh has decided to adopt the January-December financial year format from the present April-March cycle.
- With this, Madhya Pradesh has become the first in the country to adopt the change.
- With this, the next budget in Madhya Pradesh will be presented in December 2017.
- · India will discuss and take a decision on the Most Favoured Nation (MFN) status given to Pakistan, MoS for Commerce and Industry Nirmala Sitharaman announced.
- · The Union Cabinet has given its approval for National Steel Policy (NSP) 2017 to give impetus to the steel sector.
- India is the 3rd largest global producer of steel.
- · The government has declared the entire Assam as a "disturbed" area under the Armed Forces (Special Powers) Act for another 3 months.
- · The Centre has allowed emergency vehicles, including those of police, defence and paramilitary forces, to use multi colored beacons having red, blue and white colors.
- Further, duties relating to disaster management have also been permitted to use such lights.
- · The Union Cabinet has cleared a proposal allowing for the construction of 10 indigenous Pressurized Heavy Water Reactors (PHWR).
- The reactors will have a capacity of 700 MW.
- These reactors will add 7000 MW capacity and will ramp up nuclear power generation in the country.
- · The Centre is going to permit Internet on flights in India by end of August.
- International airlines, which have to switch off WiFi in Indian airspace as in-flight Internet is banned on security grounds, are also in talks with the government.
- · The Union Cabinet approved abolition of foreign investment regulator the Foreign Investment Promotion Board (FIPB).

· The government is going to bring 14 new categories, including acid attack survivors, under the Disability Act, 2016.

States

- · Uttar Pradesh state government is going to waive loans of up to 1 lakh of 'Divyangs' (differently-abled). The government also plans to hold "Samadhan Diwas" every month to resolve their problems.
- · Chairing a Cabinet meeting, Uttar Pradesh Chief Minister Yogi Adityanath has decided to celebrate January 24 as 'UP Diwas' (UP Day). The United Provinces unit was renamed as Uttar Pradesh on this day (January 24) in the year 1950.
- · Uttar Pradesh Deputy Chief Minister Keshav Prasad Maurya has flagged off 'Gauvansh Chikitsa Mobile Vans', an Ambulance Service that would cater to the needs of the cows.
- · All Uttar Pradesh government officials above the age of 50, who are found unfit by the government, will compulsorily be asked to retire, CM Yogi Adityanath ruled. The officials will be judged on the basis of performance, punctuality and public image. The CM has directed to make the list of unfit officials ready by June 30.
- · Haryana police re-launched 'Operation Durga' to ensure women's safety. The state government had started the operation earlier this month but it was stopped within a week.
- · Haryana CM Manohar Lal Khattar has announced that the state will become stray cattle free by August 15.
- \cdot Rajasthan has launched mobile patrolling units to prevent molestation, harassment or eve-teasing against women in the state.
- · The Madhya Pradesh Cabinet decided to grant the status of "living human entity" to Narmada River. The proposal to grant the status to Narmada River came after the Uttarakhand High Court accorded the status to Ganga and Yamuna rivers.
- The Karnataka government passed an order putting a cap of Rs. 200, exclusive of taxes, on the price of movie tickets at cinema halls, including multiplexes, across the state.
- · The Assam government is going to introduce a 'traditional' dress code dhoti-kurta for men and mekhela-chador for women for its employees on first and third Saturdays of every month, on voluntary basis.
- · The Assam government changed the names of all the major roads of Guwahati.
- GS Road has been renamed as Mahapurush Srimanta Sankerdev Path, BeltolaKhanapara Road is renamed as Peer Azan Fakir Road.
- · Aiming to end VIP culture in the state, the Andhra Pradesh government banned the use of Blue beacons on cars belonging to dignitaries.
- According to the new order, only emergency and disaster management vehicles have been permitted to use blue beacons.

- These beacons are generally used by police and IAS officers.
- · The Maharashtra government has declared its Bhilar village in the Satara district as India's first 'Pustakanche Gaav' (village of books).
- As many as 25 locations around the village have been turned into reader hot-spots with display of books.
- Inspired by Britain's Hay-on-Wye town, the aim of the project is to promote the "culture of reading" and boost tourism.
- \cdot Telangana has become the 1st state to introduce a logo for vehicles driven by persons with hearing impairment.
- · The Andhra Pradesh Assembly passed an amendment to its public services law to appoint Olympics silver medal-winning shuttler PV Sindhu as a Group-1 officer in the government.
- · Kerala Chief Minister Pinarayi Vijayan has launched a new scheme titled 'She Pad' under this scheme, the government will distribute sanitary pads to girls in all the schools in the state.
- · The Uttar Pradesh government has renamed its "antiRomeo" squad as Nari Suraksha Bal, which intends to curb harassment of women at public places.
- · The Maharashtra government has decided to form 'Good morning' squads to monitor and stop open defecation across the state.
- The New Delhi Municipal Corporation operates an ambulance dedicated for the treatment of trees.
- The Lucknow Police began a new drive in Uttar Pradesh capital wherein petrol will not be provided to refill the tanks of two-wheelers if the riders are found not wearing a helmet.
- · The Uttarakhand government is going to promote sites with a reputation for being haunted, as part of its ghost tourism project.
- · Goa CM Manohar Parrikar announced that buying or selling of plastic bags in the state will be an offence from July and defaulters can be fined up to 5,000 for it.

Place in the News

· Marking the formation day of Maharashtra, CM Devendra Fadnavis hoisted India's second tallest national flag in Kolhapur at 303 feet.

India's tallest flag pole, at 360 feet, is installed at the Attari-Wagah border in Punjab.

- · World's highest railway bridge which will be 35 metres taller than the Eiffel Tower is to come up over the Chenab River in Jammu and Kashmir at a cost of around Rs. 1,100 crore in around two years from now. This bridge will connect Bakkal (Katra) and Kauri (Srinagar).
- · Vishakhapatnam in Andhra Pradesh adjudged as cleanest railway station followed by Secunderabad in Telangana & Jammu Tawi.

- · India's first underwater tunnel, which was built under the Hooghly River for establishing a metro link in Kolkata, has been completed before the deadline.
- A giant tunnel-boring machine was deployed to dig the underwater tunnel that runs a length of 502 metres under the river.

Personalities

- · To mark the 156th birth anniversary of Rabindranath Tagore, India was organized Tagore cultural Festival in Egypt from 8th to 12th May.
- This Festival was organized by the Maulana Azad Centre for Indian Culture (MACIC), which is the cultural wing of the Indian Embassy in Cairo.
- · Canadian singer and songwriter Justin Bieber performed at his first ever concert in India at Mumbai's DY Patil Stadium, where he waved the Indian flag towards the end of the concert.
- The 23-year-old singer performed his songs including 'Baby' and 'Cold Water'.

Defence and National Security

- · The Indian Army successfully test-fired an advanced version of the BrahMos land-attack cruise missile in the Andaman and Nicobar Islands.
- · Israel showed off its three new F-35 stealth fighter jets recently delivered from the United States as part of an air show marking its annual Independence Day celebrations.
- The F-35 jet is the most expensive weapons system in history, costing nearly \$1.5 trillion throughout its decade and a half of development.
- · The 29th India–Indonesia Coordinated Patrol (CORPAT) has commenced at Port Blair under the aegis of Andaman and Nicobar Command.
- The bilateral exercise was held from 9th to 25th May.
- · Indian Army has planned to re-introduce Cordon And Search Operations (CASO) as a part of its counter terrorism operations after a gap of 15 years.
- The major objective behind the reintroduction of combing operations is to bring the situation in the Kashmir Valley under control.
- · In order to handle or foil possible chemical, biological or nuclear-based attacks, India will buy Anti-Nuclear and Anti-Chemical Suits from the United States for 480 crore.
- The US is close to completing a series of Arms deals with Saudi Arabia totaling more than \$100 billion which could surpass over \$300 billion over a decade.
- Saudi Arabia is leading a military coalition in Yemen which has been accused by UN of carrying out attacks that "may amount to war crimes"
- · India's indigenous Light Combat Aircraft Tejas successfully demonstrated an air-to-air Beyond Visual Range (BVR) missile firing capability.

- The Derby BVR missile destroyed a maneuverable aerial target with pinpoint precision at the Interim Test Range in Odisha's Chandipur.
- The Derby firing is a major step towards clearing BVR capabilities on LCA aircraft.
- · Two warships of the Indian Navy reached Malaysia on a 6-day visit to step up maritime cooperation, including effectively containing piracy in the Indian Ocean region.
- · India received the first artillery guns 30 years after the 1980s Bofors scandal, as two of the 145 M777 ultra light artillery guns ordered from the US arrived ahead of schedule.
- The guns will be tested at the Pokhran field firing range in Rajasthan.
- Out of the 145 guns, 120 will be assembled in India, by Mahindra Defence.
- · SIMBEX, the 24th bilateral exercise involving Indian Navy and Republic of Singapore Navy has commenced in South China Sea.
- SIMBEX "Singapore India Maritime Bilateral Exercises".
- The exercise was held from May 18, 2017 to May 24, 2017.
- · Chinese navy ships are visiting and other joint exercises with the

Myanmar and will conduct communications, search and rescue, Myanmar navy, China's Defence Ministry has announced.

- \cdot Iran has built a 3rd underground ballistic missile production factory and vowed to keep developing its missile program.
- · Preparing for North Korea's growing threat, the US Defence Ministry was shooting down an Inter Continental Ballistic Missile (ICBM) for the first time.
- · North Korea test-fired a short-range ballistic missile that flew 450 kilometers before landing in Japanese waters.

Committees/Commissions

· The Uttar Pradesh government has decided to form 'Maa' committees to keep an eye on mid-day meals served to students in state-run primary schools.

Each 'Maa' committee will have six mothers, from all sections of society, whose students are studying in that school.

· The Chitale Committee on Desiltation of Ganga has recommended a slew of measures including study of reach wise sediment transport processes along with establishing annual sediment budgets to guide de-silting activities and entrusting a technical institute to conduct sediment budget, morphological and flood routing studies that would examine and confirm the necessity of the desilting of the reach under consideration.

Head of the Committee: Madhav Chitale (Expert Member of National Ganga River Basin Authority).

· A 7-member High-Level Committee on Scouts and Guides has submitted its Final Report to

Minister for State (Independent Charge) for Youth Affairs & Sports, Vijay Goel with various recommendations.

The committee has suggested for the constitution of an Enquiry Committee to take stock of complaints and grievances and submit its report.

- The plant is situated at Rahu in Pune district of Maharashtra.
- · Gujarat CM Vijay Rupani launched Pradhan Mantri Awas Yojana Gramin Gujarat for 5 districts of the state.
- · UJALA (UK Joins Affordable LEDs for All), the world's largest efficient lighting programme, was inaugurated by Union Minister of State for Power, Coal, New & Renewable Energy and Mines, Piyush Goyal in London.
- This programme aims to increase LED penetration in UK.
- · Prime Minister Narendra Modi launched the river conservation project 'Narmada Seva Mission'.
- This project is a road-map for steps to be taken for the conservation of the Narmada River in Madhya Pradesh.
- The Minister of State for Communications Manoj Sinha has launched 3 new initiatives.
- BSNL's Satellite Phone Service: The service will cover areas where no networks are present and will be provided by INMARSAT which has 14 satellites. This service will be initially offered to government agencies and later opened for others citizen in phased manner.

- Modi announced that the bridge will be named after Dr Bhupen Hazarika, a noted playback singer, lyricist, musician, poet, and filmmaker from Assam.
- · The government has renamed the Matritva Sahyog Yojana, a scheme launched in 2010 by the Congress for pregnant and lactating mothers, as 'Pradhan Mantri Matritva Vandana Yojana'.
- · Delhi's taxi drivers have launched their own taxi app called 'Sewa Cab' to take on Uber and Ola.
- · HRD minister Prakash Javadekar launched an Anti-Ragging Mobile App introduced by the University Grants Commission (UGC) at New Delhi.
- · The government launched the 'Darwaza Band' campaign supported by the World Bank, to promote the use of toilets and freedom from open defecation across the country.
- Several Bollywood actors like Amitabh Bachchan and Anushka Sharma will help promote the campaign.
- · In support of the Indian Army, Cricketer Gautam Gambhir has started a campaign titled #SoldierSelfies.
- Under this campaign he asked people to take selfies with soldiers and post them on social media with the above hashtag.
- · Mumbai MLA Bharati Lavekar has launched India's first digital bank for sanitary pads on the occasion of World Menstrual Hygiene Day.
- · The Indian Railways has introduced 'Buy Now, Pay Later' service for passengers to book tickets online first and make payment for the reservations within a window of 15 days.
- The facility, which allows passengers to travel after five days of booking the ticket, is available for confirmed, waitlisted, and Reservation Against Cancellation (RAC) berths.

· Bihari delicacy litti-chokha will represent India at the 5-day World Street Food Congress to be held in the Philippines capital, Manila.

Agreement/Deal/Signed

- · India and Turkey have signed 3 agreements following delegation-level talks between Prime Minister Narendra Modi and Turkish President Recep Tayyip Erdogan.
- · Russia and Iran which are allies of the Syrian regime as well as the rebel supporter Turkey signed a Russia backed plan for creating safe zones in Syria.
- The pact which was signed in the Kazakh capital Astana was meant to halt fighting in the war torn Syria.
- · Nepal and China signed a framework agreement on Beijing's One Belt, One Road (OBOR) initiative, days ahead of a summit in Beijing to showcase President Xi Jinping's ambitious plan to build a modern day Silk Road.

- The US and China have signed a 10-point trade deal that opens the Chinese market to US credit rating agencies and lifts China's ban on US beef imports and shipments of liquefied natural gas.
- · India and Palestine signed 5 agreements during the 4 day visit of Palestinian President Mahmoud Abbas to India.
- · Indian Navy and the Space Application Centre have signed a MOU on Data Sharing and Scientific cooperation in the field of Meteorology and Oceanology.
- · Indian state-owned telecommunications company Bharat Sanchar Nigam Limited (BSNL) has inked agreements with Facebook and MobiKwik in order to popularize the internet and its value added services among its customers.
- Further, BSNL has also signed a third MoU with Disney Land India to offer premium online gaming services to its mobile customers.
- · IIT Kharagpur's Rekhi Centre of Excellence for the Science of Happiness and Madhya Pradesh government's 'Rajya Anandam Sansthan' (Department of Happiness) has signed a MoU to collaborate on the development of a Happiness Index for measuring the well-being of the residents of the state.

- · India and Mauritius signed 4 agreements after delegation-level talks between Prime Minister Narendra Modi and his Mauritius counterpart Pravind Kumar Jugnauth in New Delhi.

- · Prime Minister Narendra Modi participated in the International Vesak Day celebrations in the Colombo (Sri Lankan capital) as the Chief Guest.
- While speaking at International Vesak Day celebrations, Modi announced that Air India will operate direct flights between Colombo and Varanasi (Modi's Lok Sabha constituency) starting August.
- · US President Donald J. Trump was visited to Middle East and Europe.
- This is his first ever foreign trip after taking over the Presidency in January, 2017.
- · Prime Minister Narendra Modi has inaugurated the 52nd Annual General Meeting of the African Development Bank in Gandhinagar.

- This meeting was held during 22nd to 26th May 2017.
- · Prime Minister Narendra Modi visited to 4 countries in a tour lasting six days.
- The 4 Countries: Germany, Spain, Russia, and France
- Aim of this Tour: To strengthen bilateral ties.
- · Narendra Modi became the first Indian PM to visit Spain in nearly 30 years.

Bills

- · The Real Estate Act which aims to protect the interests of homebuyers by ensuring transparency has come into effect.
- · Madhya Pradesh became the 6th state in the country to pass the Goods and Services Tax (GST) Bill 2017. Uttarakhand, Telangana, Bihar, Jharkhand and Chhattisgarh had earlier passed the bill.
- The US House of Representatives approved a revised bill to repeal Obama care and replace it with a Republican healthcare plan, handing President Donald Trump his first major legislative victory. Now the bill needs to pass the Senate to become a law.
- · A law banning excessively thin models has come into effect in France, and 'unhealthily skinny' models will not be allowed to work in the fashion industry unless they provide a doctor's medical certificate.
- · The Japanese government approved a one-off bill allowing ageing Emperor Akihito to step down from the Chrysanthemum Throne, in the first such abdication in two centuries.
- · Sualgiri and Swalgiri communities of Odisha have been notified as Scheduled Castes after President Pranab Mukherjee gave his assent to the Constitution (Scheduled Castes) Order (Amendment) Act, 2017.
- The Russian parliament's lower house has passed an Anti-Suicide bill to combat the Blue Whale suicide challenge, which has caused over 100 teen deaths in the country.

Fund

- · India will give Rs. 35 crore rupees to children of freedom fighters in Bangladesh under the new 'Muktijodha scholarship' scheme in the next five years.
- · Saudi Arabia and the United Arab Emirates have pledged a combined \$100 million to a Women Entrepreneurs' Fund proposed by US President Donald Trump's daughter Ivanka Trump.
- The fund, which Ivanka first proposed during her Germany trip, will be run by the World Bank to help female entrepreneurs with the capital and networking resources to start businesses.
- The Union Cabinet has given its approval for allocating 2.5% of the Central Road Fund (CRF) for the development of the National Waterways.

Economy

- · Digital currency Bitcoin, whose value surged this month, is now worth almost double an ounce of gold, with a single coin priced at about \$2,500 (1.61 lakh).
- In just five days, Bitcoin rose to over 40% and has gone up by 88% so far this month.
- Bitcoin surpassed the price of gold for the first time in March.

Companies/Industry

- · Samsung has received approval from the South Korean government to begin testing self-driving cars on public roads in the country.
- · India's third largest IT firm Wipro has replaced its multi-colored sunflower logo, which was introduced in 1998, with a new one.
- The new logo comprises dots, which according to Wipro, represent the way the company "connects the dots" for its clients.
- · In just six months of launching its telecom operations, Reliance Jio has accounted for nearly 40% of India's broadband connections, according to data by telecom regulator TRAI.
- Reliance Jio accounted for 102.84 million users, the highest, followed by Bharti Airtel at 46.69 million broadband connections.
- · India's first private sector small arms manufacturing plant, Punj Lloyd Raksha Systems has been inaugurated in Madhya Pradesh.
- This plant is going to supply world class weapons to the armed forces in line with the India's defence indigenization programme.
- This is a joint venture between India's Punj Lloyd and Israel Weapon Systems.
- · Facebook has launched its "Express WiFi" commercially in India.
- This service is now available via 700 hotspots across four states of Uttarakhand, Gujarat, Rajasthan and Meghalaya.
- · Apple briefly touched \$800 billion market valuation, making it the world's first ever company to hit the milestone.
- The world's most valuable company, Apple is followed by Google parent Alphabet, and Microsoft in market valuation.
- \cdot Adi Godrej has handed over Godrej Group's flagship firm Godrej Consumer Products to daughter Nisaba.
- Nisaba (39) is among the youngest women to head a large-sized Indian firm.
- \cdot Paytm has signed a non-exclusive term sheet to acquire Snapdeal-owned payments platform FreeCharge.

- · Hello, the social network founded by Orkut creator Orkut Buyukkokten, has been launched in India.
- The app, which is still in beta phase, claims to let users build "personas" based on their passions and interests.
- · Moody's Investors Service downgraded China's credit ratings for the first time since 1989, saying it expects the economy's financial strength to erode in coming years as growth slows and debt rises.
- · Apple has opened its first store in Southeast Asia at Singapore's up market shopping district.

Exports/Imports

· India has imposed anti-dumping duty on a Chinese chemical used in pharma industry and aluminium foil to protect domestic industry from cheap imports.

Taxation/Trade

- · The Income Tax department activated the e-filing facility for all categories of Income Tax Returns (ITRs) for the assessment year 2017-18.
- The new ITRs have been made available for filing on the e-portal of the department.
- The government had launched all ITRs on March 31 including the one page simplified ITR1 (Sahaj) for salaried class.
- · The Income Tax department has launched a new e-facility to link a person's Aadhaar with the Permanent Account Number (PAN).
- · The Income Tax Department has launched a facility allowing people to correct errors in their PAN and Aadhaar details.
- The links for corrections are available on incometaxindiaefiling.gov.in, the department's e-filing website.
- · India added 9.1 million new taxpayers during financial year 2016-2017 due to demonetization of high-value currency notes in November, witnessing an increase of 80% annually.
- · The Centre exempted NRIs, citizens above 80 years, and residents of Jammu and Kashmir, Assam, and Meghalaya from having to mandatorily quote their Aadhaar numbers to file income tax returns.
- · Finance Minister Arun Jaitley has launched the 'Operation Clean Money' portal that aims "to create a tax-compliant society".
- The portal will identify those who have made deposits or purchases not in line with the declared income.
- \cdot The GST Council finalized tax rates for services under the GST regime, scheduled to be rolled out from July 1.
- There will be four rates for services at 5%, 12%, a standard rate of 18% and luxury rate of 28%.

- The 5% rate will be levied on transport services.
- Healthcare and education will be exempted from GST.
- The tax rates for 1,211 items with a majority of items being kept under 18%.
- Food grains will get cheaper, milk and cereals will be exempted, while sugar and edible oil will attract 5% tax.

Agriculture/Production

- \cdot Maharashtra became the first state to install first of-its-kind automated weather stations for farmers in the region.
- The state government aims to install a total of 2,065 such units at the village/mandal level across Maharashtra.

Space

- · Elon Musk-led aerospace startup SpaceX successfully launched a spy satellite into orbit for the US military.
- · The Indian Space Research Organization (ISRO) successfully launched GSAT9 also known as the "South Asia" satellite from Sriharikota, Andhra Pradesh.
- The satellite, which costs 235 crore, will provide communication, disaster management support, and connectivity to South Asian countries during a 12 year mission.
- 7 of the eight SAARC countries excluding Pakistan are part of the project.
- · The recently launched GSAT-9 / 'South Asia Satellite' became the 1st Indian spacecraft to use an electric propulsion system (EPS).
- It significantly reduced the payload weight as the satellite carried only 80kg of chemical fuel for its 12- year-long mission, 25% of the fuel otherwise needed.
- · NASA astronauts Peggy Whitson and Jack Fischer successfully completed the 200th spacewalk for the \$100- billion International Space Station (ISS).
- ISS' first spacewalk was conducted on December 7, 1998, by NASA astronauts Jerry Ross and Jim Newman.
- · ISRO is going to launch its most powerful rocket, the Geosynchronous Satellite Launch Vehicle (GSLV) MarkIII in June.
- Being termed a "game changer", it can carry satellites weighing up to 4.4 tonnes. With the introduction of the Mark-III, India will not have to rely on expensive foreign carriers to launch payloads above 2.2 tones in weight.
- · Rifath Sharook, an 18-year-old student from Tamil Nadu, has developed what he claims is the world's smallest and lightest satellite.
- Sharook, whose satellite will be launched by NASA in June, will be the first Indian student to have his experiment launched by NASA.

- The satellite, made using reinforced carbon fiber polymer, is named 'KalamSat', after former President APJ Abdul Kalam.
- · NASA paid tribute to late President APJ Abdul Kalam by naming a newly discovered organism after him.
- As of now, the bacterium named 'Solibacillus kalamii' by NASA scientist Kasthuri Venkateswaran, is found only on the ISS, which is orbiting Earth at 400 km.
- · US and Indian space agencies, NASA and ISRO will jointly develop and launch the world's biggest and most expensive earth imaging satellite, costing \$1.5 billion.
- The satellite has been named NISAR NASA ISRO Synthetic Aperture Radar.
- · American aerospace corporation Rocket Lab has become the first company to successfully launch an orbital-class rocket into space from a private launching facility.
- The test flight from New Zealand's Mahia Peninsula was also the first rocket launch for the country.
- The Indian Space Research Organization (ISRO) will commence the operation of India's own 'GPS' or positioning system, Indian Regional Navigational Satellite System (IRNSS), in early 2018.
- This would make India part of an elite group of countries that have their own positioning system.

Science and Technology

- · India will replace its Maitri station in Antarctica in next 3 to 4 years, the Ministry of Earth Sciences has announced
- To expand India's research in Antarctica, a new ship with ice-cutting facility would be procured, he added.
- · A massive ransomware Cyber Attack dubbed WannaCry, targeted computers in 99 countries including India, with more than 57,000 attacks detected so far, cyber security firms Kaspersky and Avast have confirmed.
- Russia was the worst hit country, witnessing over 70% of the affected computers, while India was third on the list.
- \cdot Cyber security agency Indian Computer Emergency Response Team (CERT-In) has issued a red alert in the country against 'WannaCry' ransomware that hit 150 countries.
- · Security researchers have identified a new malware called 'Eternal Rocks', which exploits the same vulnerability as WannaCry ransomware and is stronger than the latter.
- Similar to WannaCry, EternalRocks uses NSA tool 'EternalBlue' to spread itself from one computer to the next through Windows.

Additionally, it uses six other NSA tools that could help it spread faster than WannaCry.

- · The construction of the world's largest optical and infrared telescope has begun in Chile's Atacama Desert.
- · A malware named 'Judy' has attacked over 3.65 crore Android users through simple fashion and cooking game apps on Google Play Store, according to security firm Check Point.

Health/Diseases/Drugs

- · The Maharashtra government banned the sale of 'High in Fat, Salt and Sugar' (HFSS) food in school canteens across the state.
- Furthermore, schools have been asked to replace the junk food items with healthy food such as whole grain, home-made rotis, parathas, rice, etc.
- · Assam Health Minister Himanta Biswa Sarma has said the government-run district and rural hospitals in the state will soon provide free blood tests, X-rays, CT scans and other medical tests 24 hours a day.
- · Brazil has declared an end to its public health emergency over the Zika virus, 18 months after the outbreak in 2015.
- The number of cases dropped 95% between January and April, compared to the same period a year ago.
- The World Health Organization had lifted its own international emergency in November last year.
- · Union Health Minister JP Nadda launched new Pneumococcal Conjugate Vaccine (PCV) for pneumonia in Mandi district of Himachal Pradesh.
- · Cabinet gives its ex-post facto approval to Pan-India implementation of Maternity Benefit Programme.
- The programme now has been extended to all districts of the country from 1st of January this year.
- This Programme will provide compensation for the wage loss in terms of cash incentives so that the women can take adequate rest before and after delivery and not be deprived of proper nutrition.
- · Doctors at a Pune hospital successfully conducted India's first womb transplant by transferring a woman's uterus to her 21 year old daughter, who was unable to conceive a child.
- Womb transplantation was first performed in Sweden in a 16-hour-surgery in 2012 and the first baby, born to the recipient in 2014, was delivered prematurely by caesarean section in a healthy condition.
- · The World Health Organization (WHO) confirmed India's first three cases of Zika virus infections, all from the same area in Ahmedabad.

Energy/Gas/Oil

· India has overtaken the US to become the second-most attractive country for renewable energy investment after China.

- · Worlds biggest and most powerful wind turbines have begun generating electricity off the Liverpool coast in the UK.
- Danish company DONG Energy has installed 32 turbines, each 195 metres tall, with blades longer than nine buses combined.
- · The tiny island of Nauru (world's smallest republic) has become the 6th country to ratify the International Solar Alliance (ISA) Framework pact.
- · The Indian Institute of Engineering Science and Technology (IIEST) has successfully created India's first smart grid project, which will generate power from renewable sources of energy.
- The project will soon be inaugurated by President Pranab Mukherjee, IIEST Director Ajoy Kumar Roy told.
- · Kazakhstan, the world's biggest uranium producer, will start producing nuclear fuel for Chinese power plants in 2019 through a joint venture set up by the two countries.
- The first stage of the joint venture will produce about 200 tonnes of ready-to-use nuclear fuel assemblies a year, using technologies and equipment supplied by France.

Environment

- · The Ministry of Environment and Forests have come up with new regulations that ban the sale of cattle for slaughter.
- The rules have been notified under Prevention of Cruelty to Animals Act of 1960.
- As the Aadhaar ID for cattle process begins in Gujarat to prevent cow slaughter, a team of technicians in the state has started implanting GPS-enabled microchips in the animal's ears.

Education

- · The Visva-Bharati University has started a certificate level course to teach Mandarin (the Chinese language) to Indian soldiers which will reportedly help them gather intelligence.
- · Prime Minister Narendra Modi inaugurated the Patanjali Research Institute at Patanjali Yogpeeth in Haridwar.
- · India's leading overseas education consultant Edwise was organized by the World Education Fair across 12 cities from May 13 to 28.
- · To reduce unnecessary competition and stop education from becoming a trade, Tamil Nadu's Education Department has decided to not announce the first three ranks in the state board exams.
- The Uttar Pradesh government was making May 13 as 'no school bag day' in the state-run schools.
- · West Bengal Education Minister Partha Chatterjee has announced that school students across the state, irrespective of boards, will have to study Bengali as a compulsory subject upto Class 10.
- · The Council for the Indian School Certificate Examinations has decided to make digital copies of the mark sheets available to ICSE and ISC candidates along with the traditional hard copies from

this year.

- The students can now access the mark sheets digitally anywhere from their DigiLocker.
- \cdot To curb fraudulent admissions, the Uttar Pradesh government has made Aadhaar Card mandatory for students taking board exams in 2018.
- Students will have to fill in their Aadhaar numbers at the time of board registration in class IX and XI.
- · Prime Minister Narendra Modi has laid the Foundation Stone of the Indian Agricultural Research Institute at Gogamukh in Assam's Dhemaji district located on the Assam-Arunachal Pradesh border.
- This will be the third Indian Agricultural Research Institute (IARI).
- \cdot Modi also laid the foundation stone for All India Institute of Medical Sciences (AIIMS) at Changsari in the Kamrup District of Assam.
- · The results of the Civil Services Examination 2016 were declared by the Union Public Service Commission.
- The top three positions were secured by Nandini KR, Anmol Sher Singh Bedi and Gopalakrishana Ronanki respectively.
- · Cabinet approves setting up of new AIIMS in Kamrup, Assam under Pradhan Mantri Swasthya Suraksha Yojana.

Transport/Cars/Scooters

- · Minister of State for Railways Rajen Gohain flagged off Assam's first Shatabdi Express from Dibrugarh.
- · Considering the growth in passenger traffic and demands from airlines, the Centre approved the conversion of Vijayawada airport into an international airport.
- This makes Vijayawada the 4th international airport in Andhra Pradesh, with Hyderabad, Tirupati and Visakhapatnam already having such airports.
- · The first Chinese built passenger jet, C919, completed its maiden flight.
- The twin engine 158174 seat passenger jet, made by state owned Commercial Aircraft Corporation, features several imported elements like German landing gear and an Austrian interior.
- China is expected to overtake the United States as the largest aviation market by 2024.
- · The world's first "ladies special" suburban train, which runs in Mumbai, has completed 25 years.
- · Union Minister of State for Aviation Jayanta Sinha announced that the Centre will bring 200 airports under the UDAN (Ude Desh ka Aam Naagrik) regional air connectivity scheme.
- · Indian Railways subsidiary IRCTC was introducing Pay-on-Delivery option for buying train etickets, allowing users to pay at the time of ticket's delivery to their home.

- The service will be available in over 600 cities and would be initially available five days before the departure date.
- · Indian Railways is going to acquire End of Train Telemetry (EoTT) systems, to do away with the need of guards stationed in the last coach of trains.
- The systems will be used to establish communication between the driver and the last wagon, ensuring that the train is running with all wagons.
- · Indian Railways is going to charge 50-100 extra on the booking of lower berths as there is a high demand for these berths.
- The move, similar to airlines charging extra for window seats, is aimed to benefit senior citizens and those in need.
- · The Rajiv Gandhi International Airport (RGIA) in Hyderabad is set to become south India's first airport to go 100% LED-lit.
- · The Indian Railways' Mumbai-Goa luxury train Tejas Express, which has features like LCD screens, onboard infotainment, WiFi, CCTV, and tea/coffee vending machine, was flagged off by Union Minister Suresh Prabhu.
- · Airlander 10, the largest aircraft in the world, has successfully completed its test flight in the UK.
- Dubbed the 'flying bum' over its appearance, the 92- metre-long helium-filled airship can fly at altitudes of 6,100 metres.
- · Inaugurating India's first electric mass mobility system, Maharashtra CM Devendra Fadnavis and Union Transport Minister Nitin Gadkari flagged off 200 electric public transport vehicles in Nagpur.

- She also received the Best Director award for her directorial debut, 'A Death in the Gunj'.
- · The 70th edition of the Cannes Film Festival began in France.
- · American television host Jimmy Kimmel will host the 90th Oscars in 2018.
- · The Swedish film 'The Square', directed by Ruben Ostlund won the Palme d'Or, the top prize at Cannes Film Festival.
- The film '120 Beats Per Minute!' won the Grand Prix, the runner-up prize.

- Further, the Best Actor prize was awarded to Joaquin Phoenix for 'You Were Never Really Here' while Diane Kruger won Best Actress for 'In the Fade'.

BUDGET IN DETAIL-SECTOR-WISE

PERSONAL TAX

· Till now, there is a surcharge (of 15 per cent) on those with an income above Rs.1 crore. With the Budget introducing a surcharge of 10 per cent for people with incomes of over Rs.50 lakh to Rs.1 crore, the net has widened. There would be a rise of around 3 per cent in the income tax payout.

The new calculation for income-tax rate for this slab will be 30 per cent tax + 10 per cent surcharge on tax + 3 per cent cess on both tax and surcharge) or in total, 33.99 per cent. However, the vast majority of taxpayers with taxable incomes of Rs.2.5 lakh to Rs.5 lakh should be a happy lot as their tax burden is down by a half.

· For everyone in the above Rs.5 lakh income bracket, there is a tax rebate of Rs.12,500.

- · One reason is to persuade more people to either file their returns for the first time or declare their income honestly. First-year returns of those having income less than Rs.5 lakh will not be scrutinised unless the tax authorities have specific information against the assessee.
- · The standard deduction stands at Rs.2.5 lakh. On the next Rs.50,000, a tax rate of 5 per cent would have amounted to a tax bill of Rs.2,500. But the rebate of Rs.2,500 under Section 87A means that people with income up to this level don't have any tax burden.
- · Enforcement is likely to become stricter. Some of the data cited by the FM 7.6 million tax payers in the country, of which 5.6 million belong to the salaried class was astonishing. The government will use data analytics to get more people to file IT returns and disclose their income honestly.
- · Henceforth, cash transactions of above Rs.3 lakh will not be permitted. This was a recommendation of the Special Investigation Team (SIT) which the government has accepted.
- · No tax on income upto Rs.3,00,000/-.

CONSUMER GOODS

- · In view of the proposed GST tax expected to come in effect by July 2017, the budget has left most consumer goods untouched.

- · The holding period for long-term capital gains (LTCG) to be applicable remains constant at one year. The government stuck to its fiscal road map and made no changes to the long-term capital gains tax structure.
- · Promoters holding shares through private trusts will now have to pay 10% tax on dividend income above Rs.10 lakh.
- · At present, income by way of dividend in excess of Rs.10 lakh is chargeable at the rate of 10% for individuals, Hindu Undivided Family (HUF) or partnership firms. The rule has now been extended to include private trusts in the budget on 1st February, 2017.

· Tax experts said this would impact succession planning of promoters, since many of them own their company's shares through family trusts - especially the large conglomerates.

INFRASTRUCTURE

Oil/Gas/Electricity

- The government will build two more strategic crude oil reserves at Chandikhole in Odisha and Bikaner in Rajasthan that will take the country's strategic reserve capacity to 15 million metric tonnes, enough to maintain oil supplies for 90 days in case there is a disruption. Each will cost Rs.10,000 crore. India already has three reserves with a combined capacity of 5 million tonnes at Visakhapatanam, Mangalore and Padur. These were built for Rs.4,000 crore and nearly half of their capacity is already filled with crude.
- · Power for all, pet project of power, coal, renewable energy and mines minister Piyush Goyal, is progressing well and on track to achieve 100% village electrification by May 2018, this year's Budget has declared. The finance minister has announced an increased allocation of Rs.4,814 crore under the Deendayal Upadhyaya Gram Jyoti Yojana next fiscal.

Metro Rail

• The Budget recognised Metro Rail as the emerging mode of urban transportation. Finance minister said a new Metro Rail Policy will be announced with a focus on innovative models of financing and implementation. It will also focus on indigenization and standardisation of hardware and software. The government expects this to open up new job opportunities.

Highway Construction Accelerates

· The government will spend Rs.64,900 crore to build new highways in the new fiscal year, 12% higher than the previous allocation. The government will build and develop 2,000 km of roads for coastal connectivity. Total length of roads constructed since 2014-15 under various schemesincluding the Pradhan Mantri Gram Sadak Yojna-is about 1,40,000 km, which is significantly higher than the previous three years.

Airlines get tax cuts for small town

• The government has waived the service tax on airlines offering cheap tickets with the help of viability gap funding to help people at smaller airports that are not commercially attractive. The service charge would otherwise have been in the range of 14%.

DIGITAL ECONOMY, 2.5K CR DIGITAL TRANSACTIONS IN 2017-18

- · On the cusp of a revolution, Digital payments are poised to become the new norm in 2017, and as more people transact online, India should see new taxpayers and better transparency in income in the days to come. Budget handholds India to take the next step in Digitisation, carries forward the task of financial inclusion by proposing many measures. To achieve this, the government will employ all tools at its disposal UPI, USSD, Aadhaar Pay, etc. and will increase deployment of debit and credit card readers by banks to create a robust digital payments infrastructure.
- · The government proposes to launch two schemes to promote the use of its payments app, BHIM a referral bonus scheme for individuals and a cashback scheme for merchants.

· The finmin has proposed creating a Payments Regulatory Board within the RBI, replacing the Board for Regulation and Supervision of Payment & Settlement Systems.

A High-speed Digital Highway

· In 14 months, more than 1,50,000 gram panchayats, will have access to high-speed broadband connectivity, along with WiFi hotspots and other low-tariff digital services. FM has proposed stepping up the budgetary allocation for this to Rs.10,000 crore in 2017-18. It could lead to new models in sectors such as health, education and skills development.

More Power to Electronics Manufacturing

- · Finance minister increased the budgetary allocation for initiatives such as Modified Special Incentive Package Scheme (M-SIPS) and Electronics Development Fund (EDF) to Rs.745 crore in 2017-18.
- · India Stack which builds on JAM (Jan Dhan-Aadhaar-Mobile) and provides solutions like Unified Payments Interface, BHIM, eKYC, eSign and DigiLocker is seeing increasing uptake.

CERT Protection for Financial Sector

- · The government is finally set to implement a longstanding demand to enhance cyber protection for the country's financial systems, especially as digital transactions increase post demonetisation. The FM proposed creating Computer Emergency Response Team (CERT) for the financial sector, that will work in co-ordination with all the regulators and stakeholders in the financial sector. TDS on payments to call centres has been reduced from 10% to 2%, terming it "the only IT sector focused announcement in the Budget".
- · The government's push to enlarge India's digital footprint is set to deliver a vast slew of opportunities for startups in areas from education to healthcare, entertainment and financial technology. Allocation of Rs.10,000 crore for the Bharat Net is set to spur rural connectivity.

Startups Get More Time to choose their 3-year Tax Holiday

· Income tax rebates for startups have been extended for three out of the first seven years since

incorporation. The industry is cheering the move to allow startups - certified under the IT Act or those established after April 2016 - to carry forward losses so long as the promoters retain their holding in the company, without the earlier stipulation to maintain a 51% stake.

DIRECT TAX

- · The government has armed tax officers with sweeping powers to conduct searches and surveys, a move that's made industry jittery, saying it could lead to arbitrariness and harassment.
- · The government has eased the compliance burden on transfer pricing for domestic companies. The law mandates transactions between group companies to be priced at market rates. The Budget proposal excludes transactions between two group companies from the transfer pricing law as long as both of them do not enjoy a tax holiday.
- There is no change in the tax structure of companies with large turnover.
- \cdot Small and medium companies with a turnover of up to Rs.50 crore will be taxed at 25% against 30% now, making them more competitive. This will benefit about 96% of the companies. There is a

flip side: a company with a turnover exceeding Rs.50 crore will pay higher tax even if its taxable profit is the same as an entity with lower revenue.

- · Minimum alternate tax (MAT), meant for zero tax companies, will be scrapped only when exemptions are phased.
- · Fewer tax breaks for Arms of Foreign Cos. The government has limited tax breaks for Indian subsidiaries of foreign companies on the interest they pay to the parent. The rule will hurt Indian cos which borrow from foreign parent and associates to use interest outgo in lowering taxable income. But it is in sync with global norms aimed at ensuring MNCs pay their taxes in the country where they make profit.
- The government has prepared the transition for Indian companies to adopt Ind-AS. The accounting standards will transform balance sheets and improve transparency in financial statements.
- · Banks have got partial relief. A cut in the corporate tax rate would have reduced their tax outgo and improved valuation. Instead, they can claim higher provision.
- · The Budget has implemented key proposals of SIT like disallowing any cash transaction above Rs.3 lakh as a tax deduction & of EC to limit cash donations to Rs.2,000 to a political party.

INDIRECT TAX

· Sticking to its commitment to roll out the goods and services tax (GST) on time, the government will begin its outreach to trade and industry on 1st April, to make stakeholders aware of the benefits of the indirect tax reform. The GST Council has finalised its recommendations on almost all issues based on a consensus approach. GST's tech backbone is also getting ready as per schedule. The budget prepares the ground for its rollout.

No service tax on Insurance for armed forces

 \cdot The armed forces are not required to pay service tax on life insurance schemes as the government has exempted them from paying this levy.

Pay less for flagship IIM programmes

· Those admitted to two year, full-time post graduate programmes at the IIMs will now pay less, irrespective of whether they are living on campus as the government has fully exempted the course from 14% service tax.

Boost for local Manufacturing

- · India's ambitious Make in India programme got a boost with the budget unveiling fresh steps to correct anomalies in the indirect taxes structure to encourage manufacturing in the country.
- · Sectors including information technology hardware, capital goods, defence production, textiles, mineral fuels and mineral oils, chemicals and petrochemicals, paper, paperboard and newsprint,

maintenance repair and overhauling (MRO) of aircraft and ship repair will see changes in their customs and excise duty structure.

- · This will bring down manufacturing and compliance costs, boosting global competitiveness. In many of these cases, inputs attract higher duties than finished goods, making imports more attractive than local manufacture.
- · Customs and excise duty structure plays an important role in incentivising domestic value addition towards Make in India campaign of government.
- · Government's decision not to go ahead with the hike in service tax rate comes as a pleasant surprise to both industry and the common man.

ECONOMY

· States are budgeted to get Rs 10.85 lakh crore in resource transfer from the Centre in FY18, nearly 10% more than that in the current year. More than half of this amount, or Rs.6.75 lakh crore, is via their share in taxes while finance commission grants will yield another Rs.1.03 lakh crore. Rs.2.12 lakh crore is via scheme-related transfer.

Smart Cards for health of seniors

· Aadhaar-based smart cards containing health details of senior citizens will be introduced through a pilot project in 15 districts in 2017-18. A new LIC scheme will provide assured pension with a guaranteed return of 8% p.a. for 10 years.

PDS Sugar Subsidy Goes

· Government will not give Rs.18.50 per kg subsidy on sugar to states for selling it via ration shops from next fiscal and has allocated only Rs.200 crore in the Budget for clearing claims.

Sops for Footwear

· Leather and footwear industries will be incentivised for additional employment generation, on the lines of the textile sector. Sops include giving employers option of fixed-term employment, waiving off their contribution to PF and giving workers earning less than Rs.15,000 a month the option of not contributing to the PF. In June, the textile sector was given a Rs.6,000-crore package to create one crore new jobs over 3 years.

Government spend up across sectors

 \cdot Government has significantly enhanced allocation to infrastructure, social, rural and employment generation sectors. There is over 24% rise in rural, agriculture and allied sectors at Rs.1,87,223 crore while infra spend is up 10% to Rs.3,96,000 crore. Centre has increased spend on women and children welfare by 18% to Rs.1,84,000 crore.

Sankalp for Skilling Rs 3.5 crore Youth

· The government will launch the Skill Acquisition and Knowledge Awareness for Livelihood Promotion programme (Sankalp) this year at an investment of Rs.4,000 crore. Sankalp will provide market-relevant training to 3.5-crore youth.

Subsidies Down to 1.61% of GDP

· The allocation for subsidies is budgeted to fall further to 1.61% of GDP in FY18 from 1.9% in FY16. Fertiliser subsidy is stagnant at 70,000 crore while allocation for food is up marginally to Rs.1.45 lakh crore from Rs.1.35 lakh crore. The declining trend in petroleum subsidies continues

with allocation pegged at Rs.25,000 crore, lower than Rs.27,532 crore expected in 2017. Total subsidies, including minor ones, add up to Rs.2.72 lakh crore in FY18 against Rs.2.6 lakh crore in 2017.

Jharkhand, Gujarat to Get AIIMS

· Two new AIIMS would be set up in Jharkhand and Gujarat. Also, 5,000 postgraduate seats will be added per annum to ensure adequate availability of doctors.

Farewell FIPB, After Two Decades

- · JOB DONE e-filing and online processing of applications achieved; more reforms in foreign direct investment policy awaited; 90% proposals take automatic route; first-half year inflows rise 35% to Rs.145,000 crore in India against 5% dip globally.
- · Finance minister has proposed abolition of the Foreign Investment Promotion Board (FIPB), a move that sets the stage for more reforms in the FDI policy. Housed in the finance ministry's Department of Economic Affairs, the FIPB is an inter-ministerial body responsible for processing of FDI proposals and making recommendations for government approval.
- · It was initially constituted under the Prime Minister's Office in the wake of the economic liberalisation drive of the early 1990s. FIPB has successfully implemented e-filing and online processing of FDI applications.
- · The finance minister said a road map for the post-FIPB scenario will be announced in the next few months.

Selloff Target Fixed at Rs.72.5 k cr, Steps to Help Timely Listings

- The government has set a record disinvestment target of Rs.72,500 crore for the next financial year with plans to list railway sector firms and general insurers, explore mergers among state-run oil companies and come up with a new central public sector enterprises exchange-traded fund.
- · The disinvestment target, which experts say is achievable, has allowed the government to step up capital spending while keeping fiscal expenditure in check.
- The government expects to raise another Rs.15,000 crore in the next two months and clock the highest-ever proceeds from disinvestment at Rs.45,550 crore at the end of this fiscal year, against the initial target of Rs.56,500 crore.
- · Finance Minister budgeted for just a marginal relaxation while setting the fiscal deficit at 3.2% against a pledge of 3% for F.Y. 2017-18, even as the committee set up to review government finances had given him an 'escape clause' of up to 0.5 percentage point. The extra headroom is being used for capital spending.

Funds Spent Well, MGNREGS Gets Fresh Rs.48,000 cr. Infusion

· The government's flagship Mahatma Gandhi National Rural Employment Guarantee Scheme (MGNREGS) is likely to begin the next fiscal with a clean slate, unlike a year ago when it faced huge arrears. The government has allocated Rs.48,000 crore to the scheme in this year's Budget.

· A modest 6% hike in allocation shows that defence spending remains a low priority area for the government. The hike is unlikely to meet the impact of inflation, depreciation of the rupee and the imposition of customs duty on military imports from 2016.

AGRICULTURE

Farmers to Get Easier Access to Credit, Insurance

- · The budget has proposed various initiatives that promise to improve farmers' incomes and productivity. They include higher investment in irrigation, increased coverage under crop insurance, a fund to develop dairies, wider access to credit, and expansion of agri-markets by denotifying fruits and vegetables.
- The move to double long-term irrigation fund to Rs.40,000 crore will help increase area under irrigation and improve efficiency of irrigation. Currently less than half of 142 million hectares of farmland in the country is irrigated. The Budget also paves way for a micro-irrigation fund to be set up by National Bank for Agriculture and Rural Development (Nabard) with an initial corpus of Rs.5,000 crore.
- · The Budget has advised states to de-notify perishables from agricultural produce market committee (APMC) and expand the electronic National Agriculture Market (eNAM) to 585 mandis from 250 now. The de-notification of fruits and vegetables from APMC if it happens will be a welcome announcement because farmers will get good rate for their produce and supply chain will be reduced, leading to fall in post-harvest losses.
- · Nabard has also proposed to set up a dairy processing and infrastructure development fund with an investment of Rs.8,000 crore over three years.
- The budget proposed increased farm credit of Rs.10 lakh crore.
- · The government more than doubled the funding for crop insurance scheme, raised allocation for PMFBY to Rs.9,000 crore in FY18, from Rs.5,500 crore in 2016.
- · Coverage under PMFBY is also proposed to increase to 40% of cropped area in 2017- 18 and 50% in the following year, up from 30% now.
- · Total Budget allocation for agriculture, rural and allied sector stood at Rs.1,87,280 crore.

FINANCE AND BANKING

- · The government is considering legislative changes to confiscate Indian assets of loan offenders, who give the law the slip and flee the country; such a provision will strengthen the hands of investigating agencies.
- · India may attach local properties of loan defaulters such as liquor baron Vijay Mallya and Winsome Diamonds' Jatin Mehta, industrialists who left the country in the midst of judicial proceedings, signalling a tougher stance against future debtors seeking to escape the law of the land.
- · The government move could help reduce future wilful defaults as many highprofile borrowers, while owing thousands of crores of rupees to Indian banks, lead lives of luxury, engaging a battery

of attorneys to fight protracted courtroom battles on their behalf. India's stodgy legal system is often blamed for giving unscrupulous borrowers the latitude they would otherwise be denied.

· "We have to ensure that the law is allowed to take its own course. The government is, therefore, considering introduction of legislative changes, or even a new law, to confiscate the assets of such persons, located within the country, until they submit to the jurisdiction of the appropriate legal forum."

Payments System

- · Payments Regulatory Board will replace Board for Regulation and Supervision of Payment and Settlement Systems.
- · Board to be set up on the recommendations of Ratan Watal committee and CMs' panel for digital payments.
- · It will have the RBI governor as chairman.
- · Two RBI officials, including deputy governor in charge of payments, and three government nominees will be members.
- · It will look at payments, innovation, cyber security, customer grievance and redressal.

BANKING

- · Recovery After a Cheque Bounces to Get Easier Now. One of the biggest problems in Indian business is payments through cheques, despite uptick in digital payments. When cheques bounce due to lack of funds, the payees are at a disadvantage. FM has promised to amend the Negotiable Instruments Act so that payments happen quickly. There may be a time-frame for disposal of such cases.
- · Banks Saddled with Bad Loans Get Tax Rebate. Banks will have more incentive to make higher provisions for problem loans with finance minister giving higher tax rebate from the next fiscal year. The move will help reduce the tax liability on banks. Banks, saddled with bad loans of over Rs.7 lakh crore, have been forced to increase provisions for bad loans over the last year 2016.
- · There will be no windfall from the RBI for the government in FY18. The finance minister has made provision of only Rs.74,901 crore as surplus transfer from the RBI, dividends from banks and financial institutions.
- · Just Rs.10k crore Set Aside to Recapitalise Banks. Banks will have to tap the equity market and sell non-core assets as the Budget has allocated just Rs.10,000 crore to the lenders struggling with bad loans. In August 2015, the government had said Rs.70,000 crore will be allocated as capital to banks in phases till 2018-19. In July 2016, it allocated Rs.22,915 crore, with State Bank of India getting Rs.7,675 crore. Indian Overseas Bank got Rs.3,101 crore and Punjab National Bank got Rs.2.816 crore.
- · Withholding Tax Relief Extended for 3 More Years. The cost of capital for companies seeking foreign debt may fall amid a rise in overseas investor interest after the Budget extended a concessional 5% withholding tax for three years even for Masala bonds.

Highlights of the Railway Budget 2017-18 presented by Railway Minister Suresh Prabhu in the Lok Sabha on 1st February, 2017:

- (i) Rail PSUs to be Listed on Stock Exchanges- The shares of railway public sector enterprises will now be listed on stock exchanges to foster greater public accountability and let these companies grow to their potential. There will be a time-bound procedure for listing of identified public sector undertakings. The companies include IRCTC, IRFC and IRCON.
- · Metro Rail Policy A new policy will be announced with a focus on innovative models of implementation and financing for metro rail, as well as standardisation and indigenisation of hardware and software for the segment. This will open up new job opportunities. A Metro Rail Act will be enacted by rationalising the existing laws. This will facilitate greater private participation and investment in construction and operation.
- · Rs.1 Lakh Cr. for Safety Finance minister Arun Jaitley has proposed to create a rail safety fund, Rashtriya Rail Sanraksha Kosh, with a corpus of Rs.1 lakh crore over five years. It will draw 75% of the funds from the finance ministry while railways will raise the rest on its own. The finance ministry has already given Rs.15,000 crore to the fund. This will be used exclusively for safety related issues, a big focus area for the government after recent rail accidents. Clear guidelines will be framed for implementation of safety works under this fund.
- · Competitive Fares for Railways The tariffs of the railways would be fixed taking into consideration costs, quality of service, social obligations and competition from other forms of transport. The structure of an independent rail fare setting authority has already been worked out and the railways ministry is expected to soon get it cleared by the Cabinet.
- · Swachh Railway Bio-toilets will be installed in all rail coaches by 2019. An SMS-based Clean My Coach Service' has also been started to ensure cleanliness of passenger coaches. Plants for environment-friendly disposal of solid waste and conversion of biodegradable waste into energy are being tested at New Delhi and Jaipur railway stations. There are plans to set up such facilities at five more stations.
- · Digitisation Push Service charge on e-tickets booked through IRCTC has been scrapped to promote the use of the popular Web portal for ticketing. Cashless reservations had increased to 68% of the total from 58% after demonetisation. The aim is to digitise all railway transactions to make user experience smoother and ensure faster delivery of services.
- \cdot Station Redevelopment At least 25 stations are expected to be awarded during 2017-18 for redevelopment. As many as 500 stations will be made friendly to the differently abled by providing lifts and escalators. About 7,000 stations have been identified to be retrofitted with solar power panels in the medium term and the work is currently on at 300 stations.
- (ii) The Union Budget pegged the Indian Railways' capital expenditure for 2017-18 at Rs.1.31 lakh crore, the highest ever in the history of the national transporter. It will receive Rs.55,000 crore from the finance ministry as gross budgetary support. The railways will raise the rest from other sources.
- · The funds would be utilised for acquiring new coaches, building new tracks and electrification.
- · The railways will get Rs.18,000 crore from Life Insurance Corporation as loans, while Indian Railway Finance Corporation, the railway ministry's dedicated financing arm, will issue bonds to raise nearly Rs.22,000 crore. The rest will be mobilised through internal resources and public-private partnerships.

- · The railways has several joint ventures with state governments. Funds spent through these ventures by state governments are accounted under public-private partnerships (PPP).
- The railways will raise Rs.22,000 crore from PPPs, including its joint ventures with state governments and public sector units. Internal accruals are estimated to bring in Rs.14,000 crore. For the financial year 2017-18, the railways plans to spend Rs.21,185.49 crore on construction of new lines and Rs.650 crore on plant and machinery, among other expenditures.
- · It plans to also invest more than Rs.700 crore in public sector units, and Rs.16,790 crore in special purpose vehicles and JVs.
- · The railways plans to use funds also for constructing freight corridors, improving connectivity in Kashmir and the Northeast, upgrading signalling, re-developing stations, improving passenger amenities, acquiring rolling stock and expanding critical freight lines near coal fields and ports.
- · The railways, however, will still be responsible for its losses and all expenditure including salaries and pensions. All the burden will have to be met on its own, through revenue from carrying freight and passengers.
- (iii) The railways expects its revenue to grow nearly 10% in the next fiscal year. The budget estimates for 2017-18 have pegged the overall earnings at Rs.189,498.37 crore as against Rs.172,305 crore in the current fiscal.
- · Freight earnings are expected at Rs.118,156.50 crore in consonance with the loading target of 1,165 million tonnes (MT), which is 71.50 MT incremental over RE 2016-17. Passenger earnings in the next fiscal have been pegged at Rs.50,125 crore, up from Rs.48,000 crore in the current year.
- The railways expects passenger loading to grow a marginal 0.2%, while revenue from the passenger segment is expected to rise to almost Rs.2,000 crore. Other coaching earnings and sundry earnings have been estimated at Rs.6,494.04 crore and Rs.14,122.83 crore, respectively. The growth in coal and steel loading has been flat.
- · Operating ratio is the single most important efficiency parameter for the Railways. Operating Ratio is expected to be at 94.57%, which means the railways will be spending Rs.94.57 to earn Rs.100.

This is because of high expenditure and stunted growth in passenger and freight loading. The transporter's high pension and salary bills are also thwarting its efforts to maintain a stable operating ratio.
